Broadening horizons and promoting academic excellence

Funding programmes for researchers – doctoral programmes, international mobility, networking

As well as promoting and funding integrated degree programmes, the Franco-German University (FGU) supports cooperation in the fields of structured doctoral programmes and Franco-German research. It is particularly active in promoting collaboration and an intense pooling of knowledge and experience between researchers.



Structured doctoral programmes

Franco-German graduate schools (FGGS)

The aim of the Franco-German graduate schools is to foster structured doctoral programmes, in all disciplines, which require candidates to research in both France and Germany. The association with a third-country partner is possible. The funding primarily helps doctoral students to research and travel abroad.

Cotutelle de thèse

A Franco-German *cotutelle* system allows doctoral students to write their dissertation under the supervision of at least one professor in Germany and another in France. Students are awarded a doctoral degree from both institutions after passing the joint defence.

PhD track programmes

The aim of this call for applications is to develop Franco-German programmes in all disciplines that combine the two years of the master's programme with a further three years spent on a doctoral degree to form a five-year study period in total.



Networking opportunities

Scientific events for young researchers (workshops, summer schools)

This call for applications for the funding of research workshops and summer schools in the context of training and networking is aimed at French and German universities as well as non-university research institutes. The events are open to all disciplines, designed for a period of two days to four weeks and provide a venue for high-level academic discourse based on a specific pedagogical approach. They can be organised as individual events as well as a series of events, where events build on one another and which is aimed at building a network. Depending on the duration and design of the event, it is called either workshop (events of up to five days) or summer school (duration of more than six days).

Application deadlines for the next funding period: 15-03-2017, 15-06-2017, 15-09-2017.

Scientific events in the field of integration

With a view to making a scientific contribution to the Franco-German policy of promoting the integration of vulnerable populations the FGU decided to publish a specific call for applications which – like the call for scientific events for junior scientists – is open to French and German universities as well as non-university research institutes.

Eligible events will focus on the integration of vulnerable populations into the educational systems and/or the integration of migrants into the societies of France and/or Germany.



Depending on the duration and design of the event, it is called either workshop (events of up to five days) or summer school (duration of more than six days). Application deadline for the next funding period: 15-03-2017.

Academic Encounters / exchanges

The Academic Encounters are used as a basis for organising and holding meetings between partner universities and for supporting the development of new degree and research programmes. The funding covers travel and accommodation expenses.



Career guidance for doctoral students

Franco-German branch office ABG-UFA

The primary aim of this service provided by “ABG-Intelli’gence” and the FGU is to support French and German PhD graduates as they start their working life. The Branch guides and supports students and doctoral candidates before, during and after their doctorate by providing information, advice, a job portal, a CV database, and practical courses on preparing for the job market and working life.

The Franco-German University (FGU) is a network of affiliated member universities from France and Germany. Its administration is based in Saarbrücken. The FGU was founded as an international institution by means of an intergovernmental agreement (the Weimar Agreement) in 1997.

The FGU provides expert guidance on Franco-German university relations with the aim of enhancing university and research cooperation between the two countries.

The FGU's main tasks include initiating, coordinating and funding structured academic degree programmes for each of the three Bologna cycles. The degree programmes are subject to external academic evaluation by French and German experts.

The French and German governments, as well as the German federal states, provide equal funding to the FGU.
